The community has already been waiting 6 months. We are slower than turtles. I'm worried that it is being perceived the other way around. Because that is the feedback I am receiving directly.

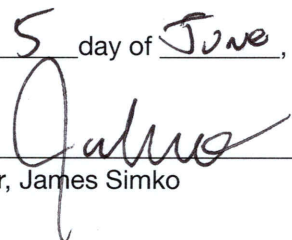
