



GENERAL UPDATES

Teaching Living Well Self Management Programs virtually to teach participants behavioral health strategies for managing chronic conditions and pain. Participants report less reliance on pain medication with behavioral interventions (distraction, action planning, physical activity, stress management, etc.).

Implementing injury prevention programming to adults that focus on improving balance, flexibility, and muscular strength to prevent falls, sprains, and other injuries from everyday activities (ex: working around the house, gardening).

HARM REDUCTION GRANT

Received funding from USU to conduct opioid overdose education and naloxone trainings to service industry employees (SIE) who work in bars, gas stations, motels, etc.

It is a targeted approach to reaching an industry that is sometimes the first to respond to an overdose.

SIEs will learn how to identify and respond to an opioid overdose, receive a CPR/Naloxone kit for use by employees, and have recovery resources on hand to promote and share.

Utah County is one of 7 participating counties and includes partnerships with several community-based organizations.

Outreach will begin in August 2023 once recruitment and instructor training is completed.

YOUTH WORKFORCE PREPAREDNESS TRAINING

Completed a grant in January 2023 to modify a workforce preparedness curriculum for youth ages 14-17 created by the CDC. National 4H Council is turning it into an engaging story-form online course for nationwide use.

Teaches youth to identify and respond to physical and emotional hazards in the workplace, rules and regulations regarding underage workers, and advocating for themselves in the workplace.

Working with Utah 4-H Youth Development to train county staff to teach the original curriculum with a focus on Utah rules and regulations.

Youth work in various industries that are physically, mentally, and socially demanding, but are at risk of injury due to their age, inexperience, and lack of training.

Can help prevent physical, social, emotional, and financial impacts of longterm injuries, recovery, treatment.
