31 **Public Hearing for Budget Fiscal Year 2023/2024.**

33 Chair Chris Robinson called the public hearing to order at 3:47 p.m.

35 **1. Jeff Silvestrini, Treasurer/Chair of the CWC’s Executive/Budget/Audit Committee**  
36 **(“EBAC”) will Present the CWC’s FY 2023/2024 Budget.**

38 Mayor Jeff Silvestrini discussed the CWC Fiscal Year 2023/2024 budget and reported that the budget  
39 was reviewed previously and no additional changes had been made.

1 **2. Christopher F. Robinson will Open the Public Hearing as Chair of the Board of the**  
2 **Central Wasatch Commission.**

4 Chair Robinson opened the public hearing.

5  
6 *Pat Shea* raised two questions. The first pertained to the proposed gondola alternative and the  
7 Interlocal Agreement. The second had to do with the budget for an outreach program with Salt Lake  
8 Community College. The outreach program related to research where credit is received for projects  
9 that the CWC felt would be necessary and appropriate.

11 Mayor Silvestrini responded to the outreach program question. He stated that it was not something  
12 he had heard about before but if someone wanted to make a request that the CWC reach out to  
13 someone at Salt Lake Community College, that could be considered in the future. He explained that  
14 it was not part of the Fiscal Year 2023/2024 budget as it had not been discussed previously. As for  
15 the first question posed by Mr. Shea, it was noted that it would be addressed during the CWC Board  
16 Meeting.

18 There were no further comments. The public hearing was closed.
