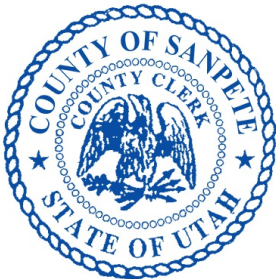
Gloria Bailey: Discussion and potential approval to be able to close Class B County Road 675 and install cattle guard.
